Gift Aid notes.

1. As your declaration covers donations you may make in the future:
 - Please notify us if you change your name or address while the declaration is still in force
 - You can cancel the declaration at any time by notifying us – it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
2. If in the future your circumstances change and you no longer pay tax on your income and capital gains to the level of the tax that your recipient charities will reclaim, you can cancel your declaration (see Gift Aid note 1 above).
3. If you are a higher rate taxpayer you yourself can claim higher rate tax relief through your Self-assessment tax return.

If you are unsure whether your donations qualify for Gift Aid tax relief, ask John Cartmell, or you can ask your local tax office for leaflet IR113 Gift Aid.
