2. If you prefer to make a one-off donation by cheque please also send that to the Hon Treasurer and not to our bank as without a pre-printed paying-in slip cheques can get lost in the system.
3. It is very helpful to have your e-mail address for quarterly newsletters which will keep you up to date with the use of your kind donation. We will not pester you! Please enter above or send to the Hon Treasurer at donations@amasango.org.uk .

Gift Aid notes.

1. As your declaration covers donations you may make in the future:
 - Please notify us if you change your name or address while the declaration is still in force
 - You can cancel the declaration at any time by notifying us – it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
2. For the Gift Aid Declaration to be valid you must pay an amount of income tax and/or capital gains tax at least equal to the tax that we reclaim on your donations in the tax year (currently 25p for each pound you give).
3. If in the future your circumstances change and you no longer pay tax on your income and capital gains to the level of the tax that we reclaim, you can cancel your declaration (see Gift Aid note 1 above).
4. If you pay tax at the higher rate you can also claim tax relief yourself in your Self Assessment tax return.

If you are unsure whether your donations qualify for Gift Aid tax relief, ask John Cartmell, or you can ask your local tax office for leaflet IR113 Gift Aid.
